#### **FY25 Developer Fees**

#### SITUATION

In accordance with Government code Section 66006 (b), the Petaluma City (Elementary) and Petaluma Joint Union High Districts must provide an annual accounting of the Capital Facilities Fund for the collection and accounting of developer fees.

Government Code Section 66006 (b) requires local agencies, including school districts, which collect developer fees, to provide an annual accounting of those fees within 180 days of the close of each fiscal year.

## Each accounting must include:

- 1. A brief description of the type of fee in the account or fund;
- 2. The amount of the fee;
- The beginning and ending balances of the account;
- 4. The amount of the fees collected and the interest earned during the fiscal year;
- 5. An identification of each public improvement on, which fees from the account were expended and the amount, and an identification of the percentage of the cost of the improvement that is being funded with the fees;
- 6. For any improvements that are funded, but have not been completed, an identification of an approximate date of completion; and
- 7. A description of each interfund transfer or loan made from the account, including the public improvement on which the transferred or loaned fees will be expended.
- 8. The amount of refunds made pursuant to subdivision (e) of section 66001.

This accounting must be made available to the public within 180 days of the end of the fiscal year. In addition, the Board of Trustees must review the information at the next regularly scheduled meeting held no earlier than 15 days after the information becomes available to the public.

The financial statements (attached) were completed and available for review on Wednesday, December 17, 2025. They are being presented to the Board on January 13, 2026.

During the 2024-25 Fiscal Year, the *Petaluma City (Elementary) School District* levied and accounted for the collection and expenditures for developer fees at the following rates in the Capital Facilities fund 25:

July 1, 2024 to June 30, 2025:

The Petaluma City (Elementary) School District collected Residential developer fees in the amount of \$2.79 per square foot of assessable space of residential construction and Commercial developer fees in the amount of 45 cents per square foot of covered and enclosed space of commercial/industrial construction; but subject to the District's determination that a particular project is exempt from all or part of these fees.

The total amount of developer fees collected for 2024-25 is \$ 288,424.49

The total amount of interest earnings for 2024-25 is \$ 74,930.13

The total amount of fair market value for 2024-25 is \$ 24,316.00

No Refunds for Developer Fees were issued during the Fiscal Year

The ending fund Balance as of June 30, 2025 is \$ 2,001,585.72

Per Government Code Section 66001(d)(D) (1)-(4) as indicated:

With respect to only that portion of the Fund remaining unexpended at the end of the 2024-25 Fiscal Year, the purpose of the fees is to finance the construction of and/or reconstruction of school facilities necessary to reduce overcrowding caused by the development on which the fees were levied. These facilities improvements are more specifically identified as follows:

- 1. Three additional leased portable classrooms at McDowell to accommodate the growth and needs of students.
- 2. Two additional portable leased classrooms at McKinley to accommodate the growth and needs of students.
- 3. One additional portable leased classroom at McNear to accommodate the growth and needs of students.
- 4. Two additional portable leased classrooms at Valley Vista to accommodate the growth and needs of students.
- 5. Geotechnical engineering services and utility locating for McKinley modular
- Three leased portable classrooms at Cherry Valley to accommodate the growth and needs of students

During the 2024-25 Fiscal Year, the *Petaluma City Joint Union High School District* levied and accounted for the collection and expenditures for developer fees at the following rates in the Capital Facilities fund 26:

July 1, 2024 to June 30, 2025:

Petaluma Joint Union High School District collected Residential developer fees in the amount of \$2.38 per square foot of assessable space of residential construction and Commercial developer fees in the amount of 39 cents per square foot of covered and enclosed space of commercial/industrial construction; but subject to the District's determination that a particular project is exempt from all or part of these fees.

The total amount of developer fees collected for 2023-24 is \$ 392,877.63

The total amount of interest earnings for 2023-24 is \$ 168,377.15

The total amount of fair market value for 2023-24 is \$53,062.00

The ending fund Balance as of June 30, 2025 is \$ 4,634,239.79

Per Government Code Section 66001(d)(D) (1)-(4) as indicated:

With respect to only that portion of the Fund remaining unexpended at the end of the 2024-25 Fiscal year, the purpose of the fees is to finance the construction of and/or reconstruction of school facilities necessary to reduce overcrowding caused by the development on which the fees were levied. These facilities improvements are more specifically identified as follows:

- 1. One additional portable leased classroom at Casa Grande High School to accommodate the growth and needs of students.
- 2. Two additional portable leased classrooms at San Antonio High School to accommodate the growth and needs of students.
- 3. Three Mini-split AC systems in Kenilworth FIT room.

#### **PLAN**

Staff has completed Resolution 2324-16 and Exhibits A - D providing an accounting of the Developer Fees collected and expended for both the *Petaluma City (Elementary) School District* and the *Petaluma Joint Union High School District* for 2024-25. The information that is included in Exhibits A - D is in compliance with Government Code Sections 66001(d) and 66006 (b). Staff recommends that the Board review the financial information and approve the resolution.
