2025-26 Opportunities for Parental Involvement

We value parent involvement and offer many ways for families to support our school community:

Classroom Volunteers

Parents may volunteer on a regular basis in their child's classroom, assist with field trips, or help during special events. Parents with limited availability can also support learning by serving as guest presenters, providing enrichment activities, or assisting with special school projects.

Room Parents

Each classroom has a room parent who collaborates with the teacher to organize class parties, help maintain the telephone directory, and coordinate parent volunteers. Room parents and volunteers may also assist with field trips and art docent lessons.

Grant School Parent Teacher Association (PTA)

All parents and staff members are encouraged to join the Grant School PTA. Meetings are held monthly, either via Zoom or in the library. Attendance is open to all, but membership is required to vote. The PTA's mission is to enhance the quality of our students' educational experience, promote parent involvement, and support families in developing skills to nurture children. The PTA also organizes school events and fundraisers.

School Site Council (SSC)

The School Site Council develops, monitors, and evaluates the Single Plan for Student Achievement and helps facilitate communication between the school and the community. The SSC is composed of parents and staff members, with teachers representing the majority. Meetings are open to the public.

School Safety

The Safety Plan was last reviewed in November 2025 with the School Site Council and the Leadership Team and will be approved by School Site Council by January 2026. Grant conducts monthly safety drills, including fire drills, earthquake drills, lockdown high and low level threat. Adult supervision with a ratio of 1:100 is provided during recess and lunch. Grant follows the suspension/expulsion policies of the Petaluma City School District. Suspension rate was 1.5% for the 2024-2025 school year. The School Safety Plan was last reviewed, updated, and discussed with the school staff in December 2025. We have been following guidelines from North Bay Security who is contracted with PCS for increasing safety measures across PCS.
