At Valley Vista Public Waldorf School, we value and encourage parent involvement through both formal and informal opportunities. Families play a vital role in shaping our school community, and their participation enhances the educational experience for all students.

Our Family Guild, English Learner Advisory Committee (ELAC), Charter Advisory Council (CAC), Team for Inclusivity, Diversity, and Equity (T.I.D.E.), TechWise, Class Coordinators, and The Foundation for Petaluma Public Waldorf provide structured ways for parents to engage in decision-making and school programs.

- Charter Advisory Council meets biweekly.
- Class Coordinators meet biweekly.
- T.I.D.E. meets monthly.
- TechWise meets three times a year.
- The Foundation for Petaluma Public Waldorf meets monthly.

Each group stays informed about school processes and outcomes through a structured data analysis protocol. All parents—whether formally involved or not—are invited to attend meetings. Agendas and minutes are shared with the school community via Parent Square to ensure transparency and communication. Additionally, our weekly newsletter keeps families updated on events, school initiatives, and goals, with opportunities for parent feedback.

2025-26 School Safety Plan

Valley Vista Public Waldorf School prioritizes the safety and well-being of all students and staff. Our School Safety Plan was reviewed on August 6, 2025, and aligns with the District Safety Plan, ensuring preparedness for a range of emergencies.

Key components of our plan include:

Regular Drills: We conduct monthly safety drills, including an annual lockdown drill, to reinforce emergency procedures.
Staff Training: In partnership with North Bay Security, teachers and staff receive training on safety protocols and drill procedures.

Emergency Preparedness: An emergency storage shed is maintained to provide water, food, and essential supplies for each student. Additionally, all classroom emergency backpacks have been updated.

Ongoing Practice & Review: Monthly drills ensure both students and staff are familiar with safety requirements.

Each year, we dedicate a professional development afternoon to reviewing:

- Basic first aid
- Emergency shut-off locations & procedures
- Student release protocols
- Tabletop emergency scenarios

By prioritizing proactive planning and training, we foster a secure, well-prepared school environment for all.
